DESCRIPTION

569J units are air-cooled condensing units which are easily connected by refrigerant lines and low voltage control wiring to matching Bryant packaged air-handling units or other suitable evaporator units to provide customized packages covering a wide range of cooling requirements. Powerful, direct-drive axial-flow fans are mounted horizontally with vertical coils, resulting in a desirable low silhouette. They are ideal for new construction or renovation where quality and performance are required.
